**PRIVATE PLACEMENT**

The Company has completed the issue of 3,170,000 shares and 1,585,000 options at 5 cents per share to two placees. For every two shares purchased there is one free attaching COYOA option exercisable at 7 cents on or before 1 December 2011.

These placements will raise \$158,500 before costs and will increase the Company's cash balance to approximately \$2.4 million, which will be predominantly used to prepare drilling at the Company's Nakru-1 and Nakru-2 prospects at Mt Nakru on New Britain.

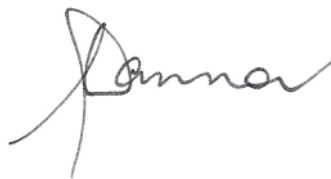
