Completion of Private Placement and Allotment of Securities

Coppermoly Limited (Coppermoly) advises that, further to the announcement on 23 December 2013, it has today completed the allotment procedures for the private placement of 52,737,609 shares at \$0.016 per share (ie 1.6 cents per share), to raise approximately \$840,000 (**Placement**).

Funds raised from the Placement will be used to fund exploration of the Company's tenements and the repayment of the outstanding convertible notes due for repayment on 21 January 2014, as well as other general working capital requirements.

An Appendix 3B (New issue announcement, application for quotation of additional securities and agreement) is attached detailing the issue.

The following information is provided as required by ASX Listing Rule 3.10.5A:

a) Details of the dilution to the existing holders of ordinary securities caused by the issue:

b) The shares were issued as a private placement in order to provide certainty that Coppermoly will have sufficient funds to repay the convertible notes due for repayment in late January 2014 and to undertake further exploration on its tenements during the first half of the 2014 calendar year.

Given the need for Coppermoly to have certainty regarding its funding, and in light of the limited participation of Shareholders in Coppermoly's July 2013 offer and shortfall offer, the Shares were issued as a private placement rather than, or in addition to, a pro-rata issue. The Board considered that the additional cost and delay involved in implementing an underwritten pro-rata offer would not be in the best interests of Shareholders in this instance.

c) The Placement was not underwritten

d) There were no fees or costs


